Pea Ridge City Council Regular Meeting January 16, 2024

The Pea Ridge City Council met in a Regular Meeting on Tuesday, January 16, 2024 at 6:00 p.m., in the Council Room at the City Hall Administration Building.

Mayor Nathan See called the meeting to order.

Mayor Nathan See opened the meeting in prayer and led those present in the Pledge of Allegiance.

Mayor See thanked the City Staff especially the Police Department, Fire Department, Street Department and Water Department. During the last few days with the inclement weather these departments have stepped up and worked tirelessly to take care of our citizens and town.

Public Comments: Boyd McNeil spoke to the Council asking when the State of the City address will be available. Mayor See stated this information will be on the March City Council Agenda as required. Mayor See also stated that concerning his other questions about current agenda items will be addressed as they are scheduled tonight.

Alderman Keene moved, seconded by Alderman Neil to approve the minutes of the December 19, 2023, Regular Meeting. The roll being called, the vote was as follows: Ginger Larsen abstained, Nadine Telgemeier voted aye; Cody Keene voted aye; and Jeff Neil voted aye. Motion passed.

Alderman Keene, seconded by Alderman Neil, moved to introduce Ordinance Number 825 by title only. The roll being called, the vote was as follows: Ginger Larsen voted aye; Nadine Telgemeier voted aye; Cody Keene voted aye; and Jeff Neil voted aye. Motion passed.

Mayor See read Ordinance Number 825 by title only, which is entitled:

AN ORDINANCE AMENDING PEA RIDGE MUNICIPAL CODE, TITLE 14, THE OFFICIAL ZONING ATLAS MAP OF PEA RIDGE, ARKANSAS, TO REZONE CERTAIN LAND BELONGING TO MERLENE DRYDEN FROM RESIDENTIAL (R-1) TO RESIDENTIAL (R-3)

Alderman Keene, seconded by Alderman Neil, moved that the rule requiring the reading of an ordinance by title only on three different days be suspended. Motion passed.

The Council discussed this Rezone with the engineer Chris Tilley and real estate agent Aaron Ingle representing the property owner. The Council had several questions and concerns about the infrastructure, the intersection and the corridor in that area. Alderman Keene moved, seconded by Alderwoman Larsen to table this rezone ordinance until the February 20<sup>th</sup> regular council meeting. Concerning Ordinance Number 830, rezone for Perrin from R-1 to R-3 Alderman Keene moved, seconded by Alderwoman Larsen to table this Ordinance until the February 20<sup>th</sup> regular council meeting.
